We are developing proposals for a sustainable aviation fuel plant and associated infrastructure.

Your views are important to us, which is why we are asking for them as part of our statutory pre-application consultation in which we are presenting detailed proposals for Lighthouse Green Fuels. This statutory consultation is being undertaken under the requirements of the Planning Act 2008. We will consider and have regard to all the feedback received in developing our proposals, before we submit our application for development consent to the Planning Inspectorate.

We have prepared a Consultation Information Booklet, which includes a description of the project elements, information about the Environmental Impact Assessment (EIA), the Preliminary Environmental Information Report (PEIR) and details of how you can respond to the consultation.

You can read our Consultation Information Booklet to help you provide us with your feedback on our proposals. You may wish to refer to the PEIR or to the shorter non-technical summary (NTS) of the PEIR for more detailed information.

Preliminary Environmental Information Report (PEIR)

We have published our PEIR and NTS setting out how we think our proposals could affect the local environment and communities. This includes any suitable mitigation measures to reduce any significant effects of the Project. Please refer to the PEIR, NTS and the Consultation Information Booklet to access information about the Environmental Impact Assessment carried out for the Project.

Transport and access

We are proposing to use a combination of road, river and rail transport during construction and operation. This includes transporting construction materials to the Project Site, and the created SAF and green naphtha offsite.

Primary construction vehicle access to the Project Site would be from Huntsman Drive, which connects to the A178 Seaton Carew Road. Options are being considered to transport smaller equipment and materials to the Project Site, including via the A1185 and A1046.

Marine infrastructure options are being considered to transport larger construction components and equipment to the Project Site, including Wilton Engineering Wharf and Clarence Wharf, and to transport the created SAF and green naphtha offsite, via Navigator Wharf.

We are also looking to use the existing rail terminal to transport feedstock to the Project Site, and transport the created SAF and green naphtha offsite.

Local community benefits

Lighthouse Green Fuels is expected to create up to 2,600 jobs during the construction phase and 840 full time jobs in the UK once fully operational, including 240 full time jobs on the Project Site. This would be the highest number of jobs for a project of this kind in Europe. We are also looking to setup or facilitate local apprenticeship schemes to support staffing requirements for the Project Site operations, which would help to upskill the local workforce.
